DELIVERY INFORMATION

Eurax Limited shall use its best endeavours to meet any delivery date but any date given by Eurax Limited is intended as an estimate only.

Delivery surcharges will apply for specific orders, direct third party addresses and items ordered in error.

Minimum order is £100 excluding VAT *FOR FREE DELIVERY* addresses situated within the UK mainland (Excluding Scottish Highlands) benefit from carriage paid delivery.

**Areas outside the UK mainland e.g. Isle of Wight, N. Ireland, Channel Islands, Scottish Isles, Isle of Man, Scilly Isles Scottish Highlands etc. and are subject to an additional carriage charge. All goods will be dispatched with a carrier that requires a signature and MUST be checked thoroughly before the driver leaves the premises.

DIRECT DELIVERIES
